

### ESL Festival

On Saturday, October 23, 2021, the very first ESL Festival (English Second Language) was held at Lakeside Junior High School. Friends for Life set up a table and spoke to attendees, handing out literature and candy, and offering our ring toss game to children for entertainment. We were able to explain abortion to a young lady (with her mom) who was interested in becoming a doctor.

### Abortion Clinics in Ohio with Expired Licenses

The State of Ohio has six surgical abortion facilities. Last fall, through a series of events, Ashtabula County Friends for Life discovered that ALL SIX surgical abortion mills in OHIO are operating on expired licenses and have been for YEARS! With help from Dave Yost's office, we were directed to an on-line form to submit a formal complaint to the Ohio Department of Health. Friends for Life sent out mass emails, one for each abortion mill with instructions on how to file a complaint. Here are the offending businesses –

Preterm, Cleveland – license expired 3/31/19

Planned Parenthood Bedford Heights Regional Medical Surgery Center – license expired 12/31/18

Northeast Ohio Women's Center, Cuyahoga Falls – license expired 3/31/19

Planned Parenthood East Health Center, Columbus – license expired 12/31/18

Planned Parenthood Southwest Ohio Region, Cincinnati – license expired 5/31/19

Women's Med Dayton – license expired 11/30/20

This is despicable that these surgical operations are permitted to operate without a license. The emails were sent to our entire email list. I know that at least a dozen FFL members submitted complaints. We were informed that the health dept. is required to respond to these formal complaints. We sent ours in mid-November of last year. We have yet to be contacted with the results. If you wish to send your own complaints, please call 466-7441 for instructions on how to do so,

### Born Alive Protection Act

Senate Bill 157, the Born Alive Protection Act was signed into law on Dec. 22, 2021. It will be effective on March 23, 2022. This bill creates protections for children who are born alive after a failed abortion attempt.

Senate Bill 157 expands abortion manslaughter to include failing to take measures to preserve the health of a child born alive after an abortion and creates a right of action for the affected mother to sue a person guilty of abortion manslaughter. The bill also bans abortion clinics from working with doctors who teach at state-funded hospitals and medical schools.

Planned Parenthood advocates said the legislation could shut down all abortion providers in Southwest Ohio. "At this moment, we're at a crisis point for abortion access in Ohio and across the country. Anti-abortion politicians have made it their job to bury abortion providers under so many TRAP laws that providing and accessing essential health care to Ohioans has become an obstacle course. Stripping abortion care from Southwest Ohio will cause havoc that disproportionately impacts our communities. Abortion is still legal in Ohio. This isn't the end, and we will continue to fight," Kersha Deibel, CEO of Planned Parenthood Southwest Ohio Region, said.

Both Women's Med in Dayton and Planned Parenthood of Southwest Ohio in suburban Cincinnati operate under state variances that include partnerships with several doctors. Women's Med's doctors are known to have ties to Wright State University's medical school and Planned Parenthood's statements suggest its doctors may have such ties, as well. WSYX, Dec. 22, 2021

## Hamilton County Elected Ohio Judge Blocks Fetal Remains Bill for Second Time

SB 27 was passed in both Ohio's House and Senate and then was signed into law by Governor DeWine in December 2020. The Bill requires proper treatment of aborted fetal remains in Ohio. Right now, the bodies of these tiny children are discarded as infectious waste.

Judge Hathaway (D) an elected Common Pleas judge in Hamilton County issued an injunction that will continue to permit the mistreatment of the tiniest of bodies. Cincinnati RTL, Feb. 4, 2022

### The Deception of Early Genetic Screening

I'll never forget the smell of the office or those green leather chairs we sat in, nervously fidgeting as we awaited some news.

I sat on the table with my stomach exposed and covered with a cold gel. My first early ultrasound with baby number three was complete. Unlike any of my previous ultrasounds, this tech remained silent the entire time. As she wiped some of the goo off me, she said the doctor would talk to us about the results. I'd had a miscarriage just six months earlier. I knew something had to be wrong.

The results? Everything looked good.

But wait? Why all the drama if the baby is fine? What followed confused me. With a very serious tone, the doctor attempted to persuade us to have genetic testing. Since I was now thirty-five (and classified as "advanced maternal age") there was a "much higher chance" that something would be wrong with the baby. He strongly advised me to get the tests so we could, "know and make the best decisions for our future . . ."

Anger flooded my pregnant body. The hormones took over and I may have surprised the doctor with my 3-minute deliberate diatribe on how, no matter what, we were having this baby. But, he got an earful. Annoyed, I left that day vowing to never again have a conversation about prenatal genetic testing. Next time, I'd stop them before the pitch. But the truth is, I continued to have regular conversations about the results of these tests. As friends from all over the country were starting and growing their families, many were talked into taking them. And, most were getting reports that terrified them.

One close friend spent three weeks believing her baby would have a rare syndrome that causes heart

defects. This was twenty-one days of feeling frightened, nervous, and stressed out—emotions that aren't assets to the health of a pregnant mom. After the baby grew a bit more, an ultrasound revealed that the baby's development looked normal. Months later she delivered a beautiful, healthy, little boy. But immediately after that genetic test, her doctor offered a choice. She could have "terminated her pregnancy" early, so as not to "risk" it. And, tragically, that test she based her decision on would have been absolutely wrong.

**A new report from the New York Times found that certain prenatal tests used to identify rare genetic disorders are inaccurate up to 85 percent of the time.** Read that number again if you didn't catch it the first time. That means that, on average, their accuracy rate is 15 percent. Back when I was in school, we called this a failing grade.

Though these tests may be somewhat reliable at predicting Down syndrome, the New York Times study shows that in the case of one specific test there was a 93 percent chance of getting a false positive. And, I wonder, why would anyone take a test that, according to probability alone, you're going to fail? And yet, the results of these tests are impacting parents and pushing some towards early abortions.

According to a report on the Daily Wire, a 2014 study shows that 6 percent of women who received a positive test result got an abortion without getting an additional test to prove there was an actual abnormality or development problem. I don't know what the numbers are to match this percentage, but **I do know that all life has value. With or without a genetic abnormality—each of these losses is a tragedy. But, any loss attributed to a false result on an unreliable test is egregious.**

The FDA does not regulate the tests nor their marketing. This means **there's also no oversight on their direct-to-consumer marketing materials—which include brochures that barely mention the chance of a false positive.** The Times also talks about how the creation of these tests has become an industry all its own with profit potential in the billions. The article reports that the number of women taking these tests may double by 2025. So what can we do? **As those committed to the cause of life, we can make sure to share this information with our friends and family members, especially those who may be looking to start a family soon.**
